**Sub: Regarding extension of provision for detention  
in respect of CWSN upto elementary level**

Dear Sir/Madam,

In compliance with the order of Commissioner of School Education, West Bengal, Govt. of West Bengal vide memo no. CSE/96, 2022 dated 19/12/2022, the undersigned is directed to notify for all concerned that the class wise year of detention(of newly enrolled CWSN or those who are already there in system but their disability have been detected in the later stage) be considered by the Head of the Institutions of respective schools based on the present academic level of those CWSN (who are in need of such consideration) considering that they may be allowed to retain in classes under the ambit of W.B.B.S.E i.e., VI-VIII for one or more year(s) in such a way that they may be able complete their elementary education upto 18 years of their age in the tune of RPWD Act,2016.

If any doubt arises to ascertain the present academic level of such CWSN-the opinion of special educators attached with SSA can be sought by the concerned school(s).


In connection with the subject mentioned above, under the reference this is to state that the School Education Department to the Govt. of West Bengal has issued a Memorandum stating the methodology shall be followed for admission of children in elementary level classes including Pre-Primary Class in all Govt. / Govt. Sponsored / Aided Primary / Upper Primary / High / Higher Secondary schools including SSKs / MSKs for the academic session -2023. Wherein, in respect to admission of the Children with Special Needs it has been stated that "The Children with Special Needs shall be admitted in such a way that they may complete elementary education within 18 years of age. "

In this context, the procedure to be followed for completion of entry of data of enrolled CWSN in Banglar Shiksha Portal for considering the Provision of detention up to elementary level classes has already been incorporated in the existing guideline for the same.

However, to get it clarified - this is further to state that, the class wise year of detention ( of newly enrolled CWSN or those who are already there in system but their disability have been detected in the later stage ) be considered by the Head of the Institutions of respective schools based on the present academic level of those CWSN (who are in need of such consideration) considering that they may be allowed to retain in elementary level classes ( Class : I to VIII) for one or more year(s) in such a way that they may be able complete their elementary education up to 18 years of their age in the tune of RPWD Act, 2016. However, in case of any doubt arises to ascertain the present academic level of such CWSN - the opinion of special educators attached with SSA can be sought by the concerned school(s).


