
Sir/Madam,

It has come to the knowledge that at some places, the use of power/electricity is not efficient. At times, the misuse of power consumption beyond school hours has been observed. It is thus advised that all school authorities be communicated to remain extremely vigilant with regard to power consumption. Any unnecessary use of electricity must be avoided at each place.

You are further requested to ensure similar vigilance with regard to power consumption in your office as well as in the offices of your subordinate officers.

You are also advised to ensure visit in the schools under your jurisdiction beyond school hour by yourself and subordinate officials, e.g. SI, Shikshabandhu etc. for random checks about any misuse of power consumption. A google format for reporting of such visit on daily basis is being sent separately.
