### ORDER

The Board had been issuing appointments letters to teachers and non-teaching staff in the government aided schools of West Bengal on the basis of recommendation forwarded to this end by West Bengal School Service Commission.

In terms of the instruction of the School Education Department vide No 1295 –SE/S/10M-01/18 dated 29<sup>th</sup> September 2022 and 244-SE/S/10M-01/18 dt: 16.03.2018 the matter of prior Verification of Antecedents and Examination of Medical Fitness was exempted in relaxation of the provisions contained in the West Bengal Board of Secondary Education (Requirement of verification of Antecedents and Examination of Medical Fitness for Appointment in the Posts of Teachers and Non-Teaching Staff) Rules 2018 for the preceding year.

Now, henceforth, all appointment letters of teachers and non-teaching staff in the schools will be issued by the Board consequent to the recommendation received from West Bengal School Service Commission as per Section 5 of the West Bengal Board of Secondary Education (Requirement of Verification of Antecedents and Examination of Medical Fitness for Appointment in the Posts of Teachers and Non-teaching Staff) Rules 2018 (Notification No:213-SE/S/10M-01/18 dated: 8<sup>th</sup> March 2018 of Principal Secretary School Education Department ) and the relaxation in the matter of prior Verification of Antecedents and Examination of Medical Fitness is hereby dispensed with.
