Please note that all questions in the Selection Test should strictly adhere to the prescribed curriculum and syllabus for class X, and there should not be any question put in the paper that may result in controversy or embarrassment tarnishing the image of the Board and the state of West Bengal. Further the question papers are to be set by Subject teacher(s) only of the school. For any breach in the norms by any school in this regard shall entail the HOI accountable for the same. Please note M.P(SE) 2025 is going to be held from 10.02.2025, therefore the schools are requested to adhere strictly to the time line, and comply with the relevant conditions notified in the Memo No.D.S.(Aca)/588/A/25/4, Date: 20.12.2023. No collective or combined Test is to be held by schools as cluster with/without the help of any external agency. The schedule for Test Examination as notified by WBBSE shall have to be followed. Credit for content and quality of questions set by schools in Selection Test shall reside with Schools, and shall no way reflect upon WBBSE's commitment towards the students. Needless to say all such schools sending Selection Test Question paper shall have updated recognition status with the Board. Submission of such questions does not of course imply that all shall be selected by Board for publication for the sake of avoiding repetition and constraint of book size.
