NOTIFICATION

To, All Heads of X Class Institutions under West Bengal Board of Secondary Education

Subject: Enrolment of Eligible Candidates for Madhyamik Pariksha (SE), 2025 in compliance of the Hon'ble High Court, Kolkata.

In compliance of the order of the Hon'ble High Court, Kolkata in WPA 2847 of 2025 dated 06/02/2025, and as the West Bengal Board of Secondary Education with the approval of the competent authority submitted before Hon'ble Court that the enrollment portal (www.wbbsedata.com) will be reopened from 06 PM (06/02/2025) to 02 PM (07/02/2025). This is for the enrollment of eligible candidates who were deprived due to dereliction on the part of concerned school, for which they did not receive their Admit Card from Board to appear in the Madhyamik Pariksha (SE), 2025.

The details for availing are as follows:

- 1. To avail the provision there in: Candidates who have successfully passed the Test Examination (Class X), having a minimum attendance of 70% in Class IX & X, may do so by following the Enrollment process that has been done before through the WBBSE portal through their concerned school. All schools must strictly adhere to the rules and facilitate the genuine candidates of the concerned institution during the enrolment process.
- 2. Submission of Documents: The concerned School shall do the needful for such deprived candidates, as noted above, in the WBBSE portal for enrollment, shall download the enrollment report for the same, and get it signed by the candidates concerned, then it is to be endorsed by the HoI, then to be submitted in original to WBBSE on Sunday (09/02/2025) between 11 AM to 02 PM. Over and above the on Saturday (08/02/2025) also WBBSE will keep its office open from 11 AM onwards for willing schools to collect the such Admit Cards.
- 3. Submission of Fees:
 - a) Cost of ₹10,000/- per candidate imposed upon school concerned of the candidate by Hon'ble High Court;
 - b) Enrollment Fee per candidate of ₹150/- + Stationary ₹35/- = ₹185/-
 - c) Late Processing Fee per candidate of ₹5000/-

Above noted fees in entirety shall be deposited with WBBSE at Nivedita Bhawan at the time of collection of Admit Card on 08/02/2025 and 09/02/2025 (between 11 AM to 02 PM), either by cash or by UPI
