Form 7 in duplicate under receipt Head "0210-0180-000-114-Medical Receipt Non-Plan-W.B." or apply online (https://www.wbifms.gov.in/GRIPS/v2/#/) and to obtain a copy of the receipt of the same for submission to the Medical Board along with an additional amount of Rs. 75/- (seventy-five rupees) only in cash being the medical examination fee.

Prior to the Medical Board, the candidates are requested to attend the following OPD(s) at NRSMC&H, Kol-14 only:

General Medicine. 2. General Surgery. 3. Ophthalmology. 4. Chest Medicine. 5.
 E.N.T. 6. Gynaecology (only for female candidates).

The following tests may also be recommended for selected candidates: Routine Blood Tests (CBC), Routine Urine Tests (Specific Gravity, Albumin, Sugar, Urea, Cast and Cells of Urine should be categorically mentioned), Creatinine, E.C.G., and a chest X-ray.

Furthermore, the candidates are instructed to comply with any advice provided by the esteemed physicians at the NRS OPD(s) and to put down "medically fit from the department's perspective" (if fit) from the relevant doctors at the same OPD(s), along with their stamps.
