

Procedure to Apply for Inspection of Original Answer Scripts and/or Certified Photocopy of Written Answer Script(s) of Madhyamik Pariksha under R T I Act 2005

A candidate of M P(S E) may apply for inspection of Original Answer Script and/or Certified Photocopy of Written Answer Script(s) under R T I Act 2005. The general norms & steps are given below. For specific information/norms (Including fees & charges, if applicable) of a particular year, the candidates are advised to follow Board's notification, generally published a week or so before the publication of M P (SE) results.

The procedure follow:

- Apply in plain white paper or in the prescribed board format available online and paste a Court Fee stamp of Rs.10/- on it.
- The application is to be addressed to the S P I O of respective region and submitted to the Regional office of the Board.

- Application must reach Board's Office (Respective Regional Office) within 180 days from the date of publication of the result of M P (SE) positively. Otherwise the application will not be considered/entertained.

- **Photo Copy of Admit Card and Mark Sheet must be attached with the application.**
- **The applicant will be informed by post/over phone regarding the date & time of inspection/collection of certified copy of written answer scrip(s).**
- **If a candidate applies for PPS/PPR, he or she will be called for inspection /collection of certified copy of written answer script(s) only after the publication of PPS/PPR results.**
- **The Application under RTI Act 2005 relates only to inspection /collection of certified copy of written answer script(s) and not for re-examination.**
- **Application(s) without Court Fee stamp &/or Full Signature of the Candidate shall be treated as rejected.**
- **Processing Fees for inspection of Original Answer Scripts /collection of Certified Copy of Written Answer Script(s) shall be as per notification published by Board before the publication of Results M P (SE).**

N B:

- **Application will be called to the respective Regional Office for Inspection of Original Answer Scripts /collection of Certified Copy of Written Answer Script(s).**
- **Inspection of Original Answer Scripts will be allowed to the candidate and one of his/her natural or legal guardian, and in case of their absence, an authorized representative of the natural/legal guardian under the provision of RTI Act 2005.**
